## Judicial Proceedings

Western National writes most classes of plaintiff and defendant court judicial bonds. Typically defendant court bonds require 100% collateral with the exception occasionally made for large publicly traded companies. Call Western National Surety for rates on other bonds not listed.

- Minimum Premium : \$100.00 \$500.00 if Collateralized
- First year premium : Fully earned at the time the bond is filed with the court
- Collateral Discount 50% fully collateralized bonds
- Pre Payment Discount: 25% on second and subsequent years

- First year premium Fully earned at the time the bond is filed with the court
- Collateral Discount 50% fully collateralized bonds
- Pre Payment Discount: 25% on second and subsequent years
