- Minimum Premium is \$100 except \$50 minimum premium where noted, \$500 for collateralized bonds with a 50% discount for fully collateralized bonds.
- 25% pre-payment discount for multi-year prepaid bonds for second and subsequent years.
- First year premium and term premiums are fully earned upon filing the bond with the obligee.
